## Study – PLA River Works Licences for Residential Use

26 October 2010

An independent study is underway to establish a method for setting PLA River Works Licence fees for residential use. It will look at a method for setting fees, how to phase in any changes, options for dispute resolution and recommend revisions to licence clauses. The study is planned to conclude in Spring 2011 and will be followed by a formal public consultation.



A message from Richard Everitt, Chief Executive, PLA:

Recent representations from resident boaters indicate that many are unhappy with the current system and all parties now wish to address this situation.

Our objectives for the study are to find a transparent, reliable procedure for setting fees which is easily understood by all, with scope for each individual situation to be assessed on its own merits within a consistent framework. It also needs to deliver an equitable return to the PLA for the use of the Thames.

We welcome the role of OPLAC (Organisation of PLA Customers), RBOA (Residential Boat Owners' Association) and the Valuation Office Agency on the steering group. We have stressed that the review should be independent, objective and must consider the perspectives of a range of interested parties, particularly the residential boaters, for whom we recognise this is an important issue. We encourage you to get in touch with OPLAC, RBOA, the independent consultant, or indeed ourselves.
