PACE offers a comprehensive Customs approved cargo inventory system in conjunction with an extensive communications network, managed by CNS. PACE provides facilities for the electronic transfer of data throughout the Port and the associated community of users.

This publication, entitled "PACE Charges", comes into effect on the 1st January 2009 and applies until replaced by a new schedule. It states the charges for use of the service.

PACE SERVICE CONDITIONS

1 PACE Processing Service

1.1 Subscription

An annual charge will be rendered for each transmitting device as recognised and individually addressed by the PACE processing service. The charge will commence from the first day of the month following the date on which operational use of the PACE processing service commences. Thereafter the subscription charge is payable monthly in advance.

1.2 Transaction Charges

A charge will be rendered to each customer, monthly in arrears, for the total transactions processed during the preceding month.

1.3 Intrastat Service

The annual fee will be charged monthly in advance.

2 Method of Payment

In order to minimise administration costs and to avoid any unnecessary disruption to the service, the preferred method of receiving payment is by Direct Debit. Payment is taken on or after the tenth day of the month following that in which the invoice is issued. Direct Debit Mandate Forms are available on request from the PLA Trade Services Department (see Foreword for contact details).

3 Due Date for Payment

Unless payment is made by Direct Debit (see above) invoices must be paid by the end of the month of issue.

4 Network Connection

Charges relating to the provision and support of the selected network connection will be invoiced to the customer by CNS and/or MCP as appropriate.

Note: The two rates of charge for a *Full Phase 2 (Inventory-linked) Import Entry (including first three items)* and a *CFSP Initial Frontier Message* are to take account of different charging regimes in respect of repositioning and turning out containers for physical examination by statutory bodies (e.g. HM Revenue & Customs). Where such amounts are charged separately, then the lower rate in the schedule will apply to an entry. If such amounts are not charged separately, then the services are provided and the charges recovered through PACE. Either the higher or lower rate will be applied to each terminal or site as a whole. The status of each terminal/site will be notified to PACE Users from time to time. The charges covered under this mechanism include those for any physical examinations by a statutory body.

The charges specifically detailed above for HM Revenue & Customs, Port Health, RPA and DEFRA checks will be rendered to the relevant clearing agent for the import container. These charges currently apply to containers handled at Tilbury Container Services.

The International Ship & Port Security Code Charge is collected on behalf of Tilbury Container Services (Site JWQ1) and is applied to all Loaded Import Containers handled at that site:
